BOARD MEETIN NOVEMBER 3, 1990
OLD FLORENCE HOSPITAL
FLORENCE, OREGON

MEETING CALLED TO ORDER 10 AM BY PRESIDENT WIL EATON.

BOARD MEMBERS PRESENT, EATON, OSTROM, WEEKLY, HEDEEN, DOVER & RIES,
ARCHIE RUFF HAD A PRIOR COMMITMENT.

ROVING REPS PRESENT WERE JOHN FORBES, VERN ARANT, BILL COX, JAN TROMBERT
AND JACK GIBBONS.

SECRETARY BOB RIES READ THE MINUTES OF THE LAST MEETING, APPROVED AS READ.

TREASURER BILL OSTROM GAVE TREASURERS REPORT AND WAS APPROVED AS READ.
BILL ALSO REPORTED THAT WE HAVE RECEIVED DUES FROM 2 NEW MEMBERS BRINGING
OUR TOTAL TO 161 MEMBERS.

PRESIDENT WIL EATON REPORTED ON THE SUMMARY JUDGMENT THAT OUR ATTORNEY HAD
FILED WITH THE COURT, WE ASKED THE COURT TO RULE WHEITHER OR NOT WE WERE
ENTITLED TO AN ACCOUNTING OF HOW FUNDS WERE SPENT BY THE DEFENTANTS.
THE JUDGE DID NOT RULE ON WHAT WE HAD ASKED FOR AT ALL. HE INSTEAD RULED
THAT EVERYONE THAT OWNED PROPERTY ETC IN COAST VILLAGE HAD TO BE LISTED
EITHER PLANTIFS OR DEFENDANTS IN THE SUIT. HE ALSO ORDERED COAST VILLAGE
(DEFENDANTS) TO SUPPLY TO US A LIST OF NAMES AND CONDITIONS OF THINGS WE HAD
SEND TO ALL PEOPLE IN COAST VILLAGE. THE DEFENDANTS HAVE 15 DAYS TO GET THIS
INFORMATION TO US AND WE HAVE 60 DAYS TO GET IT TO THE PEOPLE AND REPORT THE
RESPONSE TO THE COURT.

AS DIRECTED AT THE LAST BOARD MEETING ARCHIE RUFFS LETTER TO REALTY OFFICES
IN FLORENCE WAS READ BY PRES WIL AS ARCHIE WAS ABSENT. FURTHER ACTION ON THIS
LETTER WAS TABLE.

THE NEXT CVCPOC BOARD MEETING WILL BE HELD AT THE OLD FLORENCE HOSPITAL
DECEMBER 1, 1990 10AM. MEETING ADJURNED 12:30PM.
